

Figure 1. Output Characteristics




Figure 2. Transfer Characteristics




Figure 3. On-Resistance vs. Drain Current




Figure 4. Capacitance




Figure 5. Gate Charge





Figure 6. Body Diode Forward Voltage

Figure 7. On-Resistance vs. Junction Temperature




Figure 8. Threshold Voltage vs. Junction Temperature




Figure 9. Transient Thermal Impedance TO-252/TO-220/TO-251




Figure 10. Transient Thermal Impedance TO-220F








Figure A: Gate Charge Test Circuit and Waveform






